The Board supports the CEO of the organization serving as an international spokesperson for the organization and its mission, and considers regular travel and public speaking to be a significant part of the CEO's responsibility. As such, the Board amended its travel policy in 2008 to allow the CEO to select business or first-class air travel for domestic flights as he determines the business-related situation warrants it based on flight duration, destination, and flight availability and schedule; and that the travel policy be limited to the CEO only and that the amendment be reviewed and approved on an annual basis. All travel expenses are processed once travel is completed and are subject to a written reimbursement request with proper substantiation. In 2011, the Board reviewed this travel policy and made no changes to it.
